The Lessee agrees to pay Duck Canoe upon return said leased equipment all charges incident to breakages or damages to the leased equipment during the term of this lease. The Lessee agrees to keep the leased equipment in his custody and not to lease or rent same. Lessee acknowledges that the equipment, or dealer in similar equipment, and has not made and does not make any resolutions, warranty or covenants, expressed or implied, with respect to the condition, quality, durability or suitability of the leased equipment.

It is further specifically agreed and understood that all rental fees are for the utilization of the leased equipment and any transportation to and from the site for equipment utilization is a gratuitous and incidental service of Duck Canoe and said transportation to and from said site is solely at the option of the Lessee; and the Lessee and those claiming under him, hereby waive any and all claims growing out of the transportation or the operation of the leased equipment on land, water, or to and from the water during the period of this lease.

If you are asked to leave because of inappropriate behavior, you will not get a refund. No large or heavy loads should be loaded into these canoes.

This sport has dangers. I/we understand this and am willing to take full responsibility. I agree to not hold Duck Canoe or any of its owners or employees responsible for accidents.

This lease constitutes the full agreement between Duck Canoe and Lessee. Time is of the essence of this agreement, and the receipt of the leased equipment in good order and repair is hereby acknowledged by the Lessee. I/we hereby release Duck Canoe from any and all liability for any injuries to our persons and/or damage to our property arising from or related to our use and/or rental of equipment and canoes of Duck Canoe. I/we further assume and acknowledge the risk of injury and property damage arising from the use of canoes, paddles, safety equipment and transportation to and from the water.
